Information according to Art 13 GDPR:

The data that are required for accreditation (press accreditation form, press card) are generally stored after accreditation for the duration of the respective event; in addition, only the data that are absolutely necessary due to the applicable legal provisions or storage obligations (UGB, ABGB etc.) saved after the end of the event.
